AMENDED PROVISIONS

LUECO Bids and Awards Committee (BAC) is issuing amendments on the following provisions of herein Bid Documents in response to additional queries/comments raised by interested Bidder. To wit:

A) TERMS OF REFERENCE (TOR)

1. ITEM No. 10 – OUTAGE ALLOWANCE is amended to read as follows:

xxx

*In the case of Force Majeure Event affecting Power Supplier, Power Supplier shall continue to supply LUECO at BER, **other sources**’ or WESM Price at LUECO’s Metering points, **whichever is lower**.*

2. ITEM No. 11 – REPLACEMENT POWER is amended to read as follows:

*Replacement Power during Planned, Unplanned, and Force Majeure Outages of the source plants shall solely be for the account of the Power Supplier at BER, **other sources**’ or WESM Price at LUECO’s metering points, **whichever is lower**.*

B) INSTRUCTIONS TO PROSPECTIVE BIDDERS (IPB)
